



Warden's Report 2010

I understand, the image of a tree may be a common theme flowing across the various reports and conversations of this 2011 Annual General Meeting. The following are my thoughts, observations and experiences as first time warden at St Paul's drawn together using the analogy of congregation as a tree.

I see St Paul's as an old but not ancient tree standing firm in good soil nurtured by Peter and more recently recharged with the spiritual season from John. This is a tree that whilst mature still has plenty of good solid fruit producing years to come.

Over the year a number of the older well loved branches of the tree have died, they may have gone but their influence in shaping the tree will remain forever.

A quick backward glance at the tree of a year ago and then as it is now, reveals a first impression that it all looks the same. Yet on closer more detailed inspection it isn't, the seasons have come and gone. Gone are the leaves of past years and in their place are the branches and buds of exciting new growth.

As only one portion of the tree, I am reminded of my connection and interdependence with each and every member of the tree that is St Paul's.

During the past year the plot where the tree stands has changed, more beautiful say many, and in the months to come the landscape will change yet again in ways planned to bring new life and vitality to the tree.

May we always be a tree of movement, like the song, "*may the trees of the field clap their hands*" as an expression of God's presence with us.

Business

- **Weekly wardens meetings** – implemented process to communicate and share discussion points with Parish Council.
- **Parish Council meetings** – Modified the meeting format to ensure all matters that need to be addressed are dealt with appropriately.
- **New buildings** – considerable warden time and energy has been applied to the 164/166 community housing development and then more recently the new Kitchen/Meeting room that is scheduled to start building works on 13 June.
- **Expanding priestly leadership** - The inclusion of John in the team has enhanced the spiritual opportunities for parishioners within St Paul's, Lent studies, Companions study, on site retreat days.
- **Parish numbers** - my perception is the number of people attending each week has remained about the same as a year ago and the annual giving is about the same.

Business (*Continued*) ...

- **New blood** – it is encouraging to see new people making a connection with St Paul's and then taking steps towards a deeper involvement within St Paul's.
- **Pastoral Care/Support** – It happens, many are involved - a plan for the future is to raise the awareness of Pastoral Care, it's availability from whom, where and when as a more formally recognized service to the parish community.
- **Parish Vision Conversations** – Is St Paul's to become something new? Recently open conversations have explored questions related to where we came from, where we are now, and what we see looking to the future. The conversations will continue – suffice to say there are plenty of encouraging opportunities open to us.
- **Just Manna** – recent practical experience has highlighted the possibilities of how much may be possible with the sorts of people supported by JM. There is a saying "*from little things, big things grow*". That's how I feel, about JM.
- **Generosity of spirit and \$s** – recently I sought assistance to help Mary in Nairobi with her VISA application. The financial support from within St Paul's was fantastic and to find someone on the ground in Nairobi willing to help her was to a clear sign that God is in control.
- **LPM/PA team** – St Paul's is blessed with a team who take great care over the, "holding of the sacred space" that we all share during our various services.
- **Community Co-ordinator** – a blessing silently working in the background supporting us all.
- **Going green** – solar power was installed on the rectory.
- **Functions** – throughout the year we have been blessed with many wonderful functions where we were wined and dined magnificently.
- **A gift** – my work situation has changed and I now allocate Fridays to doing parish related activities. With our maturing congregation perhaps others will be able to consider offering a similar gift.
- **Peter** – his vision towards the future and his commitment to making a difference for people here and now, comes across in ways that touches and changes lives. Peter has a knack of testing people, of pushing people perhaps towards places they may not want to go. That can be tough but good.
- **The Team** – Peter, Chris & Michael and more recently John. We work well together, we are all quite different in nature and temperament which means we each bring a different gift to the team, charged with the leadership role at St Paul's. I may be biased, however I believe St Paul's is in good hands.

Just Manna Annual Report 2011

Thank you to all those who have supported and contributed financially and with their expertise to Just Manna. Only recently we had a parishioner wanting to organize a direct debit to Just Manna.

Since launching Just Manna in 2007 we have achieved charitable institutional status. As indicated in previous reports this enables us to accept donations and these are tax deductible. The Just Manna Committee meets monthly at the Jessups and we deal with a range of issues from business/humanitarian matters, from government compliance issues to whether we can support financially to those in need.

Over the past year the major area of focus for the Just Manna Committee has been helping the Ali Reza Irfani family, the Afghanistan family which has been granted a Special Humanitarian Visa. Leith Maddox and S.C.A.L.E.S continue to support and advise the family as they go through health checks and passport controls. As each day passes, the Just Manna Committee believes brings the Ali Reza Irfani family closer to arriving in Western Australia.

Meanwhile closer to home, Mayom has moved to live with Michael and Joan Jessup to receive the necessary support and advice to complete his Certificate IV in Human Resources, and to save some money to repay debts. His nephew, Abraham, on the other hand has married a lovely woman from Kenya and he is here in W.A. trying to bring her out to Australia.

Former parliamentarian Bill Thomas has been very helpful in providing advice on another case involving a woman from Europe who wishes to formalise her relationship with Australia, so as to provide assistance to her younger sister who has suffered from extreme post-natal depression while living here and having her children.

We have also been able to assist Australian families experiencing hardship by way of a one-off grant to help with their particular circumstances. The Committee is fortunate to have Feonagh Cooke, a school Chaplain's in-put about the needs of refugee students, some of whom have been child soldiers and are in need of special socio-cultural and spiritual rehabilitation. Feonagh has developed a program in which teenage girls utilize sewing machines to make garments. Just Manna recently authorized a small payment for the repairs to a number of machines for this program to proceed effectively.

We continue to liaise with our Federal Member for Fremantle, Melissa Parke, whose background as a Human Rights Lawyer is invaluable. On 22 June 2011 a small sub-committee of the Just Manna Committee will meet with Melissa Parke to raise a number of matters in relation to the treatment of asylum seekers in Australia.

Finally, I would like to thank our marvellous Committee for their generosity with their time, expertise and energy, and in particular Joan Jessup who has been a fantastic secretary recording all our actions and aspirations to do God's work in a humane and just manner.

Treasurer's Report

It has been a successful year for the Parish, with so much achieved, and so much more promised, as our vision comes to realisation.

During the year our loan from the Anglican Community Fund which supported the construction of the East Wall restoration, received a lump sum deposit, drawn from both our accounts, which has substantially reduced the balance owing, and therefore the interest being added, while being offset by two interest rate increases, currently now 8.1%. This payment, in addition to the regular monthly instalments was arranged with a redraw facility (if and when needed by the Parish), with so much restoration work still required on the hall, church and rectory.

General Account:

The account finished the year with a balance of \$22,555.79. There is a sizeable movement of funds into and out of the account during the course of a year. Hall bookings still remain at almost 100% constant usage, and contribute a most satisfactory amount to our income.

The new meeting room facility may be more suitable for regular small group bookings than the old studio. Weddings appear to have increased in volume since the completion of the restoration, and I have no doubt that with the completion of our new kitchen and appropriate advertising of a "wedding package", including the use of the venue for receptions as well, that the volume may increase even further.

During the year we set up and utilised the facility with the Anglican Community Fund to pay accounts by electronic funds transfer ("EFT"), and while this is a little convoluted in operation and has produced a few problems while we become totally familiar with its use, is providing our creditors with a more rapid payment of their accounts, to their satisfaction.

As mentioned earlier, the sum of \$20,000 was transferred to the Loan Account. A further substantial payment was for the purchase of a solar electricity generation complex, installed on the roof of the rectory. This amounted to \$16,890. Orders placed by parishioners with the firm for an installation privately, will contribute one extra generating panel to our setup. This was felt to be environmentally responsible by the Parish Council, and at the same time reducing our cost, particularly in light of the anticipated substantial increase in electricity charges.

The addition of our Parish Community Co-ordinator, on a salary, also meant that the BAS return became more involved, and quarterly superannuation payments had to be attended to. Without the appropriate background, this was starting to turn the treasurer's hair grey, and required the assistance of my daughter, Ainslie, who is a book-keeper. Her contribution to doing the BAS returns, squeaky clean, so to speak, and in tidying up the irregularities in my computer entries has been invaluable, and her assistance is gratefully recorded.

Everyone is familiar with the addition of Dr John Dunnill to our establishment, and now that this is official – he's got a piece of parchment to prove it – a stipend and associated expenses will have to be factored into the account in the coming year.

East End Account:

This account finished the year with a balance of \$492.96, which will be transferred to the general account. This account was set up, of course, to receive contributions to the Restoration Fund. We subsequently received a dispensation from the Diocese to allow all fundraising income to be directed towards this Fund and the loan

commitment which followed, therefore not requiring that amount to be included in the assessable income on which we pay 16% to the Diocese. That dispensation has been extended and is currently in force. To enable more conveniently to separate that income from general funds, all of that income was processed into the East End A/c. This has however proved to be error-inducing, as the treasurer attempted to cope with a sizeable workload, on a limited amount of time made available to do the work, and with the need to direct income and expenditure, associated with ALL fundraising into this account. The contributions into "Provision for Capital Expenditure" have dropped to a trickle, comprising perhaps no more than half a dozen parishioners, so it has been decided to revert back to one account for all accounting, except for these few ongoing contributions which will remain in the East End A/c, will attract a National Trust receipt for tax deductibility, and which funds will periodically be transferred to the National Trust as previously.

An amount of \$30,000 was transferred to the loan. A further \$21,825.00 was transferred to the National Trust Monthly scheduled repayments to the loan, now comprising capital plus interest calculation, of \$2000, are deducted from this account, but will be transferred to the general account from May 1st. All contributions towards our loan commitment will now be processed through the general account, and the few who make those contributions by EFT have been notified to arrange the transfer accordingly.

National Trust Account:

This account was almost exhausted by the payments to the builder, but with recent transfers now has a balance of \$22,423.74. These funds can only be retrieved against accounts from builders for restoration work and on the counter-signed approval of a heritage architect.

It is expected that this balance will increase only marginally, unless we are faced with further substantial restoration requirements, necessitating that we "re-open" the call for contributed funds as previously. It is appropriate here, to commend the response of parishioners to the original appeal for funds – your commitment was extraordinary and deserves that you give yourselves a hearty round of applause.

Loan Account:

The balance as at 30th April was \$123,861.98. Original borrowing was \$185,743.15 .

It remains for me to sincerely thank Ronny for her perseverance with the transition to EFT payments, and her continuing enthusiasm and support, which must be reciprocated in light of the huge volume of work she processes. Thanks also to the money counters – five teams – who do such a splendid job each Sunday; to Alan Albany who now provides an additional breakdown of finances for each Parish Council meeting, and a big thank you to Peter, who drags both of us out of the office each Monday morning for a coffee break down the road, which helps to keep us sane.

Rector's Report

Thank you for having me.....

"We have enjoyed a very busy year... a year of accomplishing and a year that has forever changed the shape of St Paul's. We have replaced the temporary structures of 100 years ago with a significant re-creation that takes us "Beyond the Church"... and more and more there is a growing involvement in the day-to-day life of this community. It is (we are) a sign (beacon) that really does "Shine as a light in the world to the Glory of God"." [Rector's Report 2010 – opening paragraph]

In re-reading last year's report it is heartening to see that our journey, our movement and our orientation continues to bring life and to be creative of life. Every year is different, and yet year by year there is an emerging richness. It is a richness reflected in my hopes of last year....

"In the year ahead I look forward to our continued realisation as community, one that lives and brings life into the Glory of God" [Rector's Report 2010 – closing paragraph]

This year can be more fully appreciated in our celebration of the *Paschal Mysteries* of Easter; which gives us an opportunity to reflect on our dying and rising and so too our becoming. John's facilitation of Lenten Studies engaged over 40 of us in our Easter preparations. I began the Lent journey in the weeks before Ash Wednesday by reading through the lectionary of Lent and then through the Lent Study material whilst enjoying the paradise of Bali.

And so we were well prepared for our encounter with Easter. What came 'unprepared' was the significance of the '*stone being rolled away*', reflected also in the window in the East Wall of the Church, the 'altar' Stone in the chapel floor and the wide openness of consecration offered in the embrace of the amphitheatre. There is within our community a tangible sense of movement from the Tomb. It does not mean we have previously been living in the dark; rather, we are emerging from the womb of our past. A delightful movement that takes us into a new being, and to a fuller sense of being alive.

This year's AGM report is itself a celebration, a festival of "fruits and roots".... It gives us an appreciation of both our 'Doing' and our 'Being'.

As we embrace the energy of resurrection and see ourselves entering Life from 'beyond the tomb' it will bring about a change in our being and enable us to more freely live in the Spirit. I am more and more drawn by the possibilities of 'newness' that emerge from the community of St Paul's and at the same time feel called to 'go beyond' and more fully realise ourselves 'beyond the Church'.

We are maturing as a Parish, there are many and various signs of our growth; and we are growing beyond the classical model of a Priest centred parish.

Having 'been here' for 16 years it is a good time to ask of each other "what are we going to do now that we've grown up"? And what will be the model of ministry that will enable us to continue building on the foundations we have?

Rector's Report *continued*

The community 'living in the Church precinct' will number around 23 people, and the community that spends time here during the week (beyond our Sunday worship) easily doubles that number. There is a growing commitment that is enabling of a more, wider and deeper ministry.

As we reflect on ourselves within the context of a 'faith community' we can appreciate that we are 'going beyond' the usual parochial model and becoming more participative of the future that we seek to create "in Christ".

One of the challenging (and yet delightful) movements is the discovery that our priest is not wonderful – rather *WE* are wonderful. The building up of the 'body' is a community activity that engages us all, through our giving and our sharing of ourselves, our time, our talents and our wealth.

So what might the future hold for us:

☒ A team ministry of both ordained and lay workers/ministers supported by this, and the wider, community.

☒ An 'order' of religious, creating a *new monasticism* that continues our orientation toward '*Living Faithfully in a Fragmented World*'.

I am more and more inspired, and also challenged, to go "beyond" what we have previously understood as 'Church'. In dialogue with other faiths and other cultures I believe there is more to be seen and more to our becoming who we can be in our fullness and our wholeness.

That seeking is 'rooted' here in this community but branches beyond the 'comfort' of our Church and our culture.

In developing cultures a little goes a long way, and makes me wonder if we can realise our abundance by creating a world of difference.

In the next two years we move from being 16 years together to 18 years together, time for the 'child' to move into the adult world.... and in the light of Pentecost to make manifest the Word in languages other than our own,

Community Development And Housing Activity

Community development and housing activities are undertaken in collective good faith as fellowships of members of St Paul's Anglican Church Beaconsfield and other believers. There is no one specific group responsible for, directing or controlling activities as they are realized through individuals and groups of individuals lead by the Spirit. Individuals are inspired and committed through the outpouring of Divine love for all peoples and an earnest desire to love, obey, follow and serve.

The aim of COMMUNITY DEVELOPMENT (physical facilities - e.g. a new kitchen) as distinct from COMMUNITY SERVICES (people services - the senior's luncheon), is to provide physical facilities for the community and independent living accommodation in the setting and context of (or arising from) a community faithful to Divine mission.

The St Paul's Parish Council and Anglican Church Diocesan authorities although engaged, supportive and encouraging, have a low level of obligation and responsibility for many of the activities listed below notwithstanding the many linkages of mutual interest, benefit and support.

The prime responsibility of the St Paul's Parish Council is to St Paul's Parishioners and to the central Anglican Church authorities for the church buildings and lands and for the worship activities of the church and other events that may take place in that space. For clarity, the Parish Council is not a developer of residential properties and only through the assignments of many others does it let manifest most social activities and community services on the church site. There is a strong commitment to worship, community and fellowship at St Paul's and amongst all faithful believers.

There have been times in the century plus of St Paul's existence of intense activity with the worship and the Word, with physical facilities and social activity, and times of little action, almost to the point of closing the church. In recent times, community members have been lead to undertake or contemplate physical developments in terms of:-

- the community housing activity at 11 McCleery Street;
- the beautification of the church gardens and grounds (problematical during ongoing constructions), the olive tree grove, the fountain, the fire-pit and the entry from the church to the McCleery Street houses;
- the East End wall repair, new chapel and amphitheatre facility;
- the WWI memorial restoration and front door replacement;
- the housing activity at 166-168 Hampton Road (completion June 2011);
- expanded parking facilities in association with 166-168 Hampton Road (early 2012);
- the new kitchen, plaza and meeting room (mid 2012);
- the physical re-planning of the outdoor areas in terms of public access, disabled access, parking, boundary marking, path and walkways, vehicle ingresses and egresses, landscaping and beautification, utility service provisions, etc;
- prayerful preparations for the coming Church Hall restoration and configuration for today's users (target 2013);

- prayerful preparation for the coming refurbishment and further development of the rectory, office and garage area;
- prayerful contemplation on fostering the building and service needs of "Snowlands" and the "Bali Orphanage" schools and community;
- prayerful contemplation on the longer term accommodation needs of "Just Manna" clients;
- prayerful contemplation on providing support in and through our community for those members unable to look after themselves;
- the housing activity being developed at 172 Hampton Road (by late 2012 /early 2013);
- prayerful contemplation for phases four (160 Hampton Road), phase five (Public Housing Management) and phase six of community housing development;
- prayerful contemplation and meditation for the unknown that will be made known.

The above physical developments are not for the sake of constructing buildings but to manifest Divine blessing, including the key experiences of fellowship in the body of Christ activities of worship, service, learning, spreading the good news and outreach are foremost in our minds along with sharing joy, fun, games, recreation, personal experiences, celebrations, healthy lifestyles, prosperity, amusement and entertainment, etc.

Some benefits (amongst many others) of these developments include:-

- the opportunity to establish a "Coffee Club" for social interaction and meetings;
- alternative and improved worship and education venues;
- the creation of a beautiful and spiritually inspired precinct accessible to all who seek love, faith and truth with spaces ranging from private solace areas to collective festivity areas;
- facilities to help in a practical manner the less able, dispossessed and vulnerable in our community;
- improved ability to offer hospitality and wholesome entertainment;
- opportunity for all types of creative activities to flourish and add to the precinct beauty and interest.

Beaconsfield Beyond Inc

(A Proposed Not For Profit Charitable Foundation)

- To facilitate and give leadership to activities that go beyond the domain of the Parish Council a charitable foundation is proposed namely Beaconsfield Beyond Inc. This matter is now in open progress and community consultation and input is being undertaken.
- The intent is to establish a perpetual charitable foundation to own or manage selected physical facilities and to provide financial and other resources for “good works and services” on a continuing and variable basis in accordance within an agreed constitution.
- The foundation is not being established to provide financial support for the physical fabric of St Paul's Church and property, which is a responsibility of Parishioners (there are conditional exceptions).
- The foundation will have a minimal existence and resources at this time (June 2011). When fully established it will have an initial benefice target of \$6,500,000 to be realized as its existence continues, projects develop, donations and bequests become available.
- In all probability Dama Pty Ltd the developer of the 166-168 and 172 Hampton Road and other projects will ultimately be wholly owned by the foundation as a commercial activity arm.

A New Monasticism

The notion and terminology of “new monasticism” was developed by Jonathan Wilson, in his 1998 book called *Living Faithfully in a Fragmented World*. Wilson was, in turn, building on ideas of theologian Dietrich Bonhoeffer, who said in 1935: “the restoration of the church will surely come only from a new type of monasticism which has nothing in common with the old but a complete lack of compromise in a life lived in accordance with the Sermon on the Mount in the discipleship of Christ”

Accommodation Opportunities in the St Paul's Precinct at 172 & 160 Hampton Road, Beaconsfield

A community meeting will be held in the Church Hall **Studio** at 11:15 am after morning tea on Sunday the 26th June 2011 (estimated duration 1 hour).

Please let anyone who you think may be interested in this opportunity know of the meeting (friends, neighbours, relatives, family, work colleagues, parishioners from other parishes, etc.,).

Information will be provided on the current proposed housing developments in the St Paul's Precinct. Concept plans for 172 Hampton Road will be on display at the AGM (19/06/2011) but will not be discussed until 26/06/2011. These houses are to be at a similar standard and finish to 166-168 Hampton Road (but slightly smaller) there will be 6 or 7 habitats in the complex with 3 smaller units and 4 larger units including the rehabilitated heritage house. The two storey (+ lofts) complex will be around a central courtyard with some community facilities attached. Parking should be available for 2 vehicles for each habitat. Unit prices are targeted in a range at under \$350,000 for a small 1 bedroom unit and up to \$700,000 for the heritage house and the largest 2 bedroom loft unit.

If you attend the meeting and are interested in this accommodation a follow-up meeting should be arranged with Rodger Philpott in the week following 27th June to July (appointment slot can be arranged on the Sunday or by e-mail). Participants will need to be financial contributors to the project in order for it to happen but there is individual flexibility for financial arrangements.

John Dunnill: A Short Introduction

What background do I bring to St Paul's as Associate Priest? In my twenties I was an English teacher in schools, and I taught Theology at Murdoch University from 1992 until last year. My ministry experience includes parishes, hospital chaplaincy, adult education, and since coming to Perth in 1992, shared leadership in the formation programme for Anglican ministry. A turning point for me was undertaking formation as a spiritual director, and I offer this on an individual basis and also through leading regular retreats and workshops around the diocese. Another turning point was the three months we spent in Bali last year, experiencing life among Western and Balinese Christians who live and work with people of many faiths and backgrounds. I have had a long-standing interest in symbolism and symbolic action, so right now (apart from my two days at St Paul's) I'm busy completing a book on the Biblical and Christian understanding of sacrifice. After that, who knows?

STP Sycamore Tree Project Report

STP is a world-wide Restorative Justice Programme which has the unique feature of bringing together unrelated victims of crime and serving prisoners, usually one day a week for about two months, to discuss what has happened and try to find a way forward. They tell their painful stories and listen deeply and carefully to one another, displaying compassion and concern for the other. It is as simple and difficult as that. By the end of the course, it is quite obvious that there has been a dramatic change of heart or healing of wounds in the majority of participants. Public consciousness has given us stereotypes of these people as either (on the one side), emotional wrecks intent on revenge or compensation, or (on the other), unfeeling or insane monsters. The reality is that both sides retain their basic humanity and the ability to show grace under pressure and enormous courage.

Prison officers (surely the most cynical and cautious of people) frequently tell us "*whatever you are doing keep it up – because it is working*". Victim graduates speak of healing and the recovery of power in their lives. Five members of St Paul's Church have so far participated in the programmes (some several times) and I am sure they would be willing to share their experience with you.

Sandesh, was discovered by Marie on her visit this year and was suffering from multiple fractures caused by his father... He is again smiling now that we have help in getting him through surgery.

Postcard – Snowlands School

It took the taxi driver a while to reach the new school..... at the border of the main city. The air is a lot better and the environment too. But no wrong imaginations we have a lot to do still!!

I got a room in the girls' house, on the first floor. I share the floor with all the girls plus the youngest boys..... The ground floor is full of all other younger boys and the bigger and older boys got their own house in the other part of the new school.

More space for the cloths is still an illusion; we definitely need cupboards and places where we can put the old metal boxes from all the children. Also hanging up clothes on the roof, we have no lines, which is one of the next projects we will start. Bathroom and kitchen are getting installed slowly. (A lot too slowly... let's see) the kitchen at the moment is a small house with sheet plate rooms, which are so old that it rains inside through howls. Anyway we get food, but the dining hall is still a question mark. Half of the kids eat on the floor or in their rooms and the smaller ones share the last 6 tables.

We still fight with the problem of the boring, monotone food, and a lot of children are not eating properly. I could ask another volunteer to send us money to start with fruit and meet once a week again.

The grounds in front of the houses are flooded with too much rain.... We miss both, football and basketball playing possibilities at the moment, why we fight against boredom even more than before and walk to a place where we can play both as much as we can. The disadvantage of that place is a 30min walk, so we can only take a certain amount of children with us.

The new classrooms are a lot better than the old ones. First of all we have finally enough rooms for all classes from class one till ten and the rooms are bigger, brighter. The only thing what I worry is that after heavy rain, some of the walls don't seem to be dry enough and we have sometimes in the first floor wet parts in the wall.

In my opinion a lot of the children look healthier and better, while others don't. I think it will always be like this, there are too many problems, which are burden on each child.

Suraj's family who we met on our visit to Kathmandu in 2009 have been moved from their 'slum' into a small apartment and are doing well with our ongoing support.

- Apartment leased for mother & children.
- Nisha now attending school in Kathmandu

After the death of their mother, the five Tamang children were left in the care of their father who had little income and an alcohol problem. They were living in a small wooden house some 2hours outside of Kathmandu. We have now set up a home/schooling for them in Kathmandu

- Apartment leased for family
- House mother employed & in residence
- All children now attending school

And in Indonesia.....

There is delight in the Yayasan Widya Guna (which translates into English as **"Foundation for Children's Education."**)

We have completed the final payment on the Gamelan instruments for the children and are now looking at supporting individual children via educational sponsorship.

A Discussion Paper on our Liturgy

As we reflect on our movement as a community during the AGM, it is also timely to look at the liturgical practices that give shape to our worship. It is often commented (for positive and negative reasons) that the church never changes, however there are always changes (every week) for our liturgy is very much *our* work, and we of course change week-by-week.

Here we seek to identify some of the changes that we have experienced and also invite discussion of changes that may also be emerging in our liturgical patterns.

The Church

Is both an icon of who we are, and also our place of worship – it holds our liturgical movements. The changes that we have undertaken are a significant commitment from us as a community to the Divine Presence in this place. And they are so beautiful they really do reflect *our* offering of “Glory to God”.

The new chapel and amphitheatre are both consecrated spaces, and so extend the sacred space of the 1905 Church. They also do much more for they reflect our building on the foundations we have inherited and take us ‘beyond the Church’ opening us out in a wide embrace in the direction of the rising Son.

The window in the East wall of the Church has both brought in new light and also takes us ‘beyond the altar’, again these ‘movements’ seem reflective of our movement as community.

How does the physical precinct of the church resonate for you?

The Prayer Book

Provides us with a ‘framework’ for our worship and gives us our routine. It is our *Regula Fidei* or Rule of Faith. However, it is we who give expression to the various orders of liturgy that the book contains. The book represents a tradition and foundation, and at the same time offers us an invitation to translate its context into the present.

What is the “Rule of Faith” that gives shape to your life?

The Service Sheet (Order of Service)

We have now brought the full order of service into the service sheet, and that means that we no longer juggle hymn and prayer book, nor do we distract ourselves as we seek to skip pages in order to stay on the same page as everyone else. This is more than a movement of convenience, it invites us to be more focussed, and offers us an opportunity to introduce variation to the words ‘contained’ in the prayer book. Once again it reflects our community engagement with the liturgy and our desire to express all that the liturgy brings into reality.

What has changed in your own experience of prayer and worship?

Our Music & Choir

Blessed as we are with both musicians and singers, we have many opportunities to express ourselves in song and in harmony. We sing with one voice (albeit in many different keys), and that gives us a glimpse of the breath of creation that sings us all into being. Church music is again a changing and evolving part that

Discussion Paper on our Liturgy *continued ...* gives expression to our worship. We seek to reflect both the theology of our community and the ‘energy’ of the liturgy through our music.

What songs sing in your heart, and how does music enable your prayer life?

The Members of 'One Body'

The seasons of the liturgical year and the festivals of the Church calendar give us a reference point for the ebb and flow of life. As a community, we also experience an ebb and flow of those who gather each Sunday to worship God. Always we are blessed with each other's presence, and perhaps our growing is related to the movement and engagement we find within the community.

What part do you play in the life of the Community and what 'gift' are you to the whole?

Are there enough opportunities for you to find yourself 'here'?

Symbols

From *Simnal cake* to *Siva Nataraja - the Cosmic Dancer*, we are invited into contemplative reflection through the symbols we employ and via the various presentations of the altar and sanctuary, particularly for the celebration of our major festivals. We use symbols to enable our 'seeing beyond' the obvious and to enable a looking through the everyday into the eternal. As a community we too are a symbolic representation of the Body of Christ, and members of that one body.

Sparkle Club Report 2011

"St Paul's All-Ages Religious Knowledge Learning Experience" has been welcoming children of all ages, and we continue to tailor our teaching to be multi-layered so all can benefit and be challenged. We continue to organise our subject material into "blocks" of 6-12 weeks. Last year we covered Paul of Tarsus over eight weeks, which included his life story and the traditional Seven Letters. Each week, the children placed the "letter" onto the corresponding city on a large map of the Mediterranean. We then started a series on the life-story of Jesus in chronological order beginning with Advent last November, and continuing all the way to Pentecost this year. Our next topic will be "The Kingdom of God", then we will do a series on the saints. We focus mainly on the New Testament, because many adults today who were in Sunday school in the past grew up knowing all the stories of the Old Testament but almost nothing from the New Testament, which is where the main Christian story is. We also teach the children how the Bible was put together, from which languages it was translated and how to look up verses.

The children always amaze us with their fresh insights and ability to understand challenging issues. We only have 60-90 minutes with the children, so we try to pack as much quality instruction into that time as possible. We start with a short teaching and use visuals like pictures or objects to enhance learning. Then we often do some games and follow that with a craft that reinforces the teaching of that day. One of the games we have played this year is "put yourself in the shoes of another" where the children swap either shoes or an item of clothing, then walk around pretending to be that person. The children find this game hilarious. We then gather around and each child tells what it is like to be another person, to be to gain some insight into how others think and feel.

We teach the traditional version of (protestant/Anglican) Christianity, and our education approach is inspired by both the Classical and Steiner theories, and based on these three objectives:

1. Character Development - ie virtues, stories of biblical heroes and saints, parables, inspiring sayings of Jesus and Paul, proverbs, etc.
2. Foundations – To expand the child's knowledge of what the Bible is, who wrote it, its history, Christian history, liturgy and traditions, the main characters etc. The goal is that the child will develop a framework, or "pegs", for later knowledge to be acquired and discerned.
3. A Positive Experience of church and Christianity - ie enjoyable activities, fun and games, laughter etc, so the kids associate positive experiences.
