HOW TO LEAVE A BEQUEST TO ST. PAUL'S BEYOND INC.

You will need to have a legally established Will if you intend to make a testamentary bequest to St. Paul's Beyond Inc. You can use the following clause for inclusion in your Will:

"I LEAVE to St Paul's Beyond Inc., of Beaconsfield in the State of Western Australia for its General Purposes the sum of [state amount in words] from my estate."

NOTE: There are other options to the above wording depending on your intentions, however it is important to correctly nominate St Paul's BEYOND Inc. with the correct name.
